Pleasant Valley View Family Swim Club, Inc. (Herein referred to as V.V. Pool) agrees to allow the undersigned group to use the pool and pool facilities within the fenced area on _____ . The hours of this agreed period are _____ to _____ .

_____ (Herein referred to as User) agrees to keep the pool and pool property in the same relative condition as when received. It is expressly understood and agreed that the V.V. Pool shall not be responsible for any lost articles, damage to User's and/or their guests' property, or injuries to person participating in activities during the agreed use period.

User agrees to pay or reimburse V.V. Pool for any damage to articles such as furniture, equipment and/or any other property in the possession of V.V. Pool.

Users shall maintain all rules and regulations and guests during the hours of the agreed period (see attached) V.V. Pool agrees to provide at least one (1) qualified lifeguard during the agreed period to maintain water safety and its rules and regulations. User and their guest agree to fully comply with such rules and regulations. User agrees that any lifeguard(s) on duty has complete discretion to immediately terminate this agreement upon violation of the rules or regulations.

In the event of inclement weather, User shall be reimbursed on a pro-rata basis for the time unused during the use period. The agreement may be cancelled at the beginning of the agreed period as a result of bad weather, should this be necessary, the User would receive a full refund.
